C7 residential visit to Caythorpe Court, Lincolnshire
Monday 5th July to Friday 9th July 2027
Deadline to confirm place Friday 28th September 3:00pm

As you may recall at the C7 Intake Evening in June, we launched the C7 summer residential to families. This residential opportunity to the PGL centre Caythorpe Court runs from Monday 5th to Friday 9th July 2027. As part of our Enrichment Programme at Honywood, we offer learners opportunities for learning outside of the classroom where they can develop relationships with their peers and staff, and develop their confidence and resilience.

Caythorpe Court is a PGL-run centre offering activities such as paddle boarding, wall climbing, archery, climbing walls and zip wires. (Photos from previous cohorts' visits are available to view on our Facebook page!) Learners will travel by coach from Honywood to Caythorpe Court on Monday 5th July at 9:30am. The children will be on site at Caythorpe for the week in the accommodation blocks. Each room contains 4-6 beds (bunk beds) with a bathroom attached. The booking is on a full board basis; however, they will require a packed lunch on the first day as they will arrive after lunchtime. They will need to bring a sleeping bag or quilt and pillow as the site supplies a bottom sheet only. They will depart from Caythorpe on Friday 9th July after lunch, aiming to return to school around 4:30pm. A meeting will be held nearer the time giving families more information about the visit arrangements such as timings and a kit list.

The total cost of the week, which includes all transport costs, accommodation and full board is **£635.00**. This is payable via instalments below. Please note that the initial deposit and second deposit are non-refundable in the event that your child withdraws from the trip. required by this deadline as once we have confirmed numbers with PGL, they release any beds we no longer require (they have a waiting list from other schools).
